INTERIM SUPERINTENDENT'S REPORT

Dr. Alvarez reported that the work of the referendum has begun. He noted that district administrators have had several meetings regarding planning and scheduling, including one earlier this afternoon that focused on renovations to the elementary classrooms. He stated that we are well under way with this project, thanks to Kelly Ippolito's oversight.

He noted for the record that earlier this evening there was a Board Retreat, which opened to the public at 5:30 pm. During that time there was a presentation and discussion of the 2021-2022 District Goals--which include student learning initiatives, social-emotional supports for students and staff, communication strategies, operations improvements and technology enhancements. These were discussed at length during the Board Retreat. Special thanks to Business Administrator, Kelly Ippolito, incoming Superintendent, Melissa Signore, and Curriculum Supervisor, Kim Dowling, for their contributions. The Board will vote on these goals at its meeting of June 22.

He informed the Board that the administration is making strides in filling staff vacancies for the 2021-2022 school year. To date, 8 of 10 teaching positions have been filled. He also referenced the appointment of Ms. Alyson Puzzo as the next Assistant Principal of Holdrum Middle
