#### INTERIM SUPERINTENDENT'S REPORT

Dr. Alvarez reported that the big news this week was the return of our Kindergarten and grade one students to a 5-day-per-week program. By all accounts, things went well the first two days. He gave kudos to the teachers and the elementary school principals for being well prepared; and to the students who have been most resilient during this time.

He also commented that the District is investigating a COVID-19 positive case at Holdrum Middle School. This particular case involves the possible exposure of many students and staff. As a result, Holdrum will be remote again on Wednesday, November 18. This added day will allow the continuation of contact tracing and provide additional time for the receipt of testing results. He advised that the District will assess the status of this situation late in the day on Wednesday and make a determination for the remainder of the week.

Finally, he noted that the District is still waiting to hear from the NJDOE regarding approvals and reimbursement dollars with regard to the proposed building referendum. He stated the District should have heard by the end of September, since it met all of the required timelines.

#### **BOARD SECRETARY'S REPORT**

Ms. Ippolito reported that there has been no update as of yet from the SDA regarding the district's referendum application. Ms. Ippolito has sent emails to the Director to follow-up, but has not yet received any response.

Ms. Ippolito mentioned that this year's audit will be taking place soon but has not yet been started.
