#### SUPERINTENDENT'S REPORT

- The Superintendent reported the district's QSAC designation as a high-performing district and noted the breakdown of scores can be found on the BOE Agenda.
- The Superintendent thanked everyone who took an interest in the school board elections. She announced that there were no official results but they are expected shortly.

MINUTES - NOVEMBER 15, 2022

The Superintendent thanked the teachers, staff, administrators, and BOE members for their dedication to the students of River Vale and wished everyone a Happy Thanksgiving.

#### **BOARD SECRETARY'S REPORT**

Ms. Ippolito reminded everyone that the December 13th Board meeting has been rescheduled to December 22nd due to the district going out to bid for the next phase of the renovation projects at Holdrum.

Ms. Ippolito reminded Board Members that there is an NJSBA Bergen County meeting scheduled for November 30th. Should anyone wish to attend please advise her office.

Ms. Ippolito also indicated, as was discussed previously with the Buildings & Grounds Committee, that the district will be entering into a Project Labor Agreement with the Bergen County Building Trades Council for the next phase of the Holdrum renovations project due to the strict timeframe of the project and the need for skilled workers. Some of the "pros" of entering into such an agreement include only accepting bids through Union contracts for skilled and trained Union tradesmen and the Union would agree to be responsible for paying the prevailing wages and benefits. One of the items that was negotiated for the roofing component of this project is that the roofer has agreed to a "make-up" day on a Saturday at straight pay time, not time and a half, should the roofers not be able to work during a weekday for rain or such other instance. Also embedded in the PLA contract is a labor harmony clause wherein laborers cannot stop work to strike. They can strike, however, Management would negotiate any issues that arise but the work would not stop. To be able to participate in the PLA, a project needs to be over \$5 million dollars, for which the Holdrum project qualifies. We are one of the first districts to enter into one of these PLA's; however, there are municipalities already using this program, as has the Township which has also recently entered into a PLA for their new safety complex.
